[V100]'S "EVERY 15 MINUTES REMOTE DRAWING CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station [KDVV]-FM ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website www.[v100rocks].com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the [V100]'s "EVERY 15 MINUTES REMOTE DRAWING" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, plus residents in the following Kansas counties are also eligible: Atchison, Leavenworth Douglas and Franklin, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days. - 3. **How to Enter.**
 - Remote Broadcast: Attend a remote broadcast conducted by Station on March 15, 2023 from 6:30pm through 8:30pm at Hooters, 6100 SW 10th Ave, Topeka, KS 66615 and complete an entry form. Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.
- 4. Winner Selection. On or about every fifteen (15) minutes on March 15, 2023, Station will [select one (1)] winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant(s) [must be present to win and will be contacted] using the telephone number provided with the entry or via PA system announcement and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner(s) are final and binding in all matters related to the Contest. Failure to respond to the initial verification will result in disqualification.

- 5. Verification of Potential Winner, THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
