## [V100]'S "REMOTE DRAWING CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station [**KDVV**]-**FM** ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.[v100rocks].com**, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the [V100]'s "REMOTE DRAWING" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

## 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. **Remote Broadcast:** Attend a remote broadcast conducted by Station on August 19, 2023 from 11:00am through 1:00pm at 2880 SE California Ave, Topeka, KS 66605 and complete an entry form. **Limit one** (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.

4. **Winner Selection.** On or about 10:00am on August 21, 2023, Station will select one (1) winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant(s) will be contacted using the telephone number provided with the entry or via PA system announcement and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner(s) are final and binding in all matters related to the Contest. Failure to respond to the initial verification will result in disqualification.

- 5. Verification of Potential Winner.
