V100'S "REMOTE DRAWING" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station **KDVV-FM** ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.v100rocks.com**, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the V100'S "REMOTE DRAWING" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, plus residents in the following Kansas counties are also eligible: Atchison, Leavenworth Douglas and Franklin, excluding Florida and New York residents, age twenty-one (21) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days. - 2. **Contest Period.** The Contest entry period begin at 12:00pm CST on April 6, 2024, and will run through 2:00pm CST on April 6, 2024. (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

Remote Broadcast: Attend a remote broadcast conducted by Station on April 6, 2024, from 12:00pm through 2:00pm at Cox Communications, 1109 SW Wanamaker RD, Topeka, Ks 66604 and send a text message with the designated keyword given on-site and spelled correctly, to 877-297-1077. Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.

4. **Winner Selection.** On or about [10:00am] on April 8, 2024, Station will select one (1) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification

contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
